2:00 Land Use Thematic Scenarios and Results –Peter Claggett, LUWG Coordinator

Peter will present eight thematic future land use scenarios for all counties intersecting and adjacent to the Bay watershed, including results of a comparative analysis of nutrient and sediment loads between thematic land use scenarios at both county and state scales. The eight thematic land use scenarios include the Historic Trends Group (Historic Trends, Forest Conservation without Zoning, Growth Management without Zoning, Agricultural Conservation without Zoning), and the Current Zoning Group (Current Zoning, Forest Conservation with Zoning, Growth Management with Zoning, Agricultural Conservation with Zoning).

2:40 Agricultural Stormwater EPEG Recommendations –Loretta Collins, AgWG Coordinator

Loretta will present the recommendations developed the Agricultural Stormwater Expert Panel Establishment Group (EPEG) regarding the representation of agricultural stormwater management practices as a BMP in the Phase 6 Watershed Model.
