#### III. Round Robin and Chesapeake Bay Program Updates

- PA DEP: Lancaster County is holding a public meeting to share its draft WIP III plan. Lancaster
  was one of the four pilot counties for the Community Clean Water Toolbox and is the first of the
  four to complete its draft plan using the toolbox.
- Jennifer Starr: Jennifer is taking over as Coordinator of the Bay Program's Local Leadership
  Workgroup. The workgroup is an effort to expand knowledge and capacity of local elected
  officials throughout the watershed. The workgroup died down when the previous coordinator
  retired, but re-energizing the workgroup has become a priority. The first meeting was Thursday,
  October 11. They are looking for a mix of people representing local governments, state

# V. Action Team Updates

- The WIP Engagement Action Team held its first call October 1. About 20 members joined the action team, so there's great interest, which speaks to the importance of successful WIP Engagement efforts. The focus of the first call was taking stock of collective knowledge and understanding what each member and their organization is doing related to WIP development and engagement. Some jurisdictions are continuing in a similar way to the Phase II WIPs, some are taking a new approach, and there are some differences in the way local governments are being engaged. Action team members represent strong and diverse expertise: communications specific, local government/local stakeholder outreach, community/public outreach, funding specialist, environmental program specialists, etc. The WIP Engagement Action Team will aim for calls every two weeks. The next call will be a deeper dive into the needs and challenges that organizations are facing around WIP III engagement and how the action team can support these needs.
- The two GIT-funding projects that we proposed were both accepted for funding. We anticipate

forming action teams related to managing these projects in the beginning of 2019. One project is a behavior-change training for the Chesapeake Bay Program partnership with a pilot project focused on landowners protecting their SAV. The other is a social marketing project aimed at coastal property management, with a likely focus on living shorelines.

### VI. Deep Dive: Fish Consumption Advisory

- Whether or not it is safe to eat fish out of contaminated bodies of water can differ even in different parts of the same body of water. Organizations put out fish consumption advisories to let people know, but they often vary significantly between different regions and come off as very governmental.
- Toxic Contaminants, Outreach and Diversity teamed up to find a way to make these advisories more accessible.
- The fish consumption workgroup is putting together a user guide, which brings together the information from the group's literature review, community outreach, etc. The guide will mirror press packets it will include background information, press release, sample social media, etc., and then organizations can take it and make it their own.
- They would like the Communications Workgroup to make a toolkit with sample case studies for the appendix of user guide. At the last Communications Workgroup retreat, we did sample social marketing strategies based on theoretical case studies. This would be a similar concept for the fish consumption advisory. For example: one audience might be a dense, multicultural urban population; one might be suburban, Hispanic subsistence fishers; etc. There will be 4-5 demographic scenarios. Localities will be able to use these as a sample strategy to work off of based on their own demographics.
- This should be a quick project, done by the end of the year. At the retreat, we came up with quick sample strategies within 20 minutes.
- Questions/discussion:
  - So far, the fish consumption infographic is in English and Spanish. They hope to expand to many other languages; but it is also designed to be understood just from the images.
  - Has AWS been involved? Yes. At Festival Del Rio, AWS and Anacostia Waterkeepers will
    combine with CBP to have a filleting demonstration during a fishing activity down at the
    water to show how to safely prepare fish
  - Nonprofit groups that are utilizing this would be another great resource for creating the sample strategy. Kristin will send around to her communications workgroup and could be a good topic for their call later this month.
  - Case studies could potentially emulate stormwater and MS4 outreach programs
