



## Beyond 2025 Steering Committee

The Beyond 2025 Steering Committee advises the development of recommendations to meet the Chesapeake Executive Council (EC) charge (October 2022) to the Principals' Staff Committee (PSC) on charting a course beyond 2025.

- Prioritize and outline the next steps for meeting the goals and outcomes of the Watershed Agreement leading up to and beyond 2025.
- Report back to the EC at its 2024 annual meeting with recommendations that continue to address new advances in science and restoration, along with a focus on our partnership for going beyond 2025.

Subsequently the CBP established a Beyond 2025 Steering Committee consisting of partner signatories, federal agencies, advisory committees, and GIT representatives.
