CBP Diversity, Equity, Inclusion and Justice (DEIJ) Statement

- **Decision:** The MB reviewed the CBP DEIJ Strategy, and an accompanying Strategy Endorsement Statement, and recommends the Principals' Staff Committee formally endorse the strategy at their May meeting. In addition, the MB approved a CBP DEIJ Statement and recommends it to the PSC for approval and recommendation for adoption by the Executive Council during its August 2020 meeting.
