As a follow-up from the February Quarterly Progress meeting, leaders of the Diversity Workgroup will present to the MB the final Diversity, Equity, Inclusion and Justice (DEIJ) Strategy and its key recommendations. They will seek feedback from MB members on how the DEIJ Strategy should be formally endorsed and what should be included in the CBP DEIJ Statement (one of the key recommendations in the strategy). In addition, they will present the Diversity Workgroup's recommendation on a revised leadership target for the diversity outcome and share the workgroup's draft list of existing internship and entry career programs and opportunities.

III. Wetland and Stream Mitigation Action Team Proposal

(11:20 a.m. – 12:00 p.m.)

The Chesapeake Bay Program partnership instituted a policy in the 1990's whereby wetlands and streams restored under voluntary measures can be recognized toward meeting Chesapeake Bay water quality goals, but those restored under compensatory mitigation and mitigation banking cannot be accounted for in the modeling tools. Pennsylvania DEP contends that the ineligibility of these projects is not reflective of current comprehensive Chesapeake Bay Program partnership strategies, and Pennsylvania DEP advocates for the inclusion of these projects as recognized BMPs across all jurisdictions

<u>Action/Decision requested</u>: Support for the formation of an action team to deliberate and report on current stream and wetland mitigation accounting and reporting procedures. This action team would provide options and potential changes to Partnership policies for MB decision by December 2020.

### IV. Approval of a New Non-TMDL Land Use Classification Scheme (12:30 p.m. – 12:50 p.m.)

The Water Quality Goal Team recently approved a proposed "land use classification scheme" to help: improve mapping of floodplain and tidal wetland zones; correct over-estimation of ag land and turf grass in some counties; and correct errors and inaccuracies. The new scheme is based on updated decision rules and additional ancillary data to better translate land cover into land use. The proposed classification will not adversely impact the Phase 6 land uses nor impact the WIPs, Milestones, or annual progress runs.

<u>Action/Decision requested</u>: Management Board approval of the proposed new Land Use Classification Scheme.
