Help Needed – Stakeholder Recommendations for Scorecard Effort (Almost Complete)

- Request to Management Board: identify **potential stakeholder users** for scorecard feedback meetings.
 - Management Board members submitted names and contact information of recommended stakeholders to participate in virtual engagement sessions to provide input on the Bay-Wide Climate Resilience Scorecard
 - Majority of jurisdictions provided suggestions (12 names total; NY, MD, WV, PA, DC)

Help Needed – Indicator Guidance (In Progress)

- CRWG Request to Management Board: Identify **utility behind climate indicators** being selected
 - Management Board Request: Provide a descriptive list of which climate indicators have been prioritized based on requests from other GIT workgroups, recommended time frames for updating, and potential responsible party for maintaining.
 - Coordinate with STAR leadership and the Status and Trends Workgroup
 - **Due Date: List due 2 weeks before March MB meeting**

Help Needed – Climate Change BMP Funding Plan (In Progress)

- CRWG Request to Management Board: Establish **funding plan** for research agenda on **climate change impacts to BMP performance (function, design, placement)** to inform needed resilience actions.
 - Management Board Request: Identify which BMPs from, "Phase III WIP BMP's: Drivers for Implementation between 2019-2025," have the greatest need for climate change research based on workgroup judgement in coordination with the WQGIT.
 - Management Board will review the posted information in advance and come prepared to discuss, prioritize, and identify next steps.
 - **Due Date: 2 weeks before March MB meeting.**
- Results from currently funded BMP climate resilience assessments (Virginia Tech projects with STAC and NOAA) will be available by September 2021 and can be used to help bolster this research agenda.

Help Needed – Workgroup Capacity/Resources (In Progress)

- CRWG Request to Management Board: Support **more staff resources** for Climate Resiliency Workgroup (CRWG full-time staffer, technical analyst)
 - Management Board Request: Draft Logic and Action Plan prepared to include actions that the Climate Resiliency Workgroup feels necessary to maintain progress toward achieving both climate resiliency outcomes.
 - The version provided to the Management Board will also identify those actions which the Workgroup feels that they do not have the resources to complete within the 2-year timeframe.
 - The Workgroup is encouraged to work with partners to identify any actions which partners may be able to take on, and to suggest any other solutions for Management Board consideration.
 - Due Date: April 30th with extension
 - The Management Board will be prepared to help identify and discuss resource solutions that can support a path forward for both the climate resiliency outcomes
 - **Due Date: April 30th with extension**
