Draft Actions/Decisions

Clarifying the Process for Updating CAST-21

<u>Decision</u>: The MB declined to revisit the 2016 decision on updating the model at this time. Therefore, that decision stands as-is and the default position is approval of final model updates every two years. If there are any issues of concern with a future model update, the WQGIT and/or any MB member may petition the MB for consideration. The WQGIT may, if they so choose, draft a clarification statement for MB approval.

Black Duck and Wetland

Action: The Habitat GIT will work with Jeff Sweeney and others as appropriate to draft a brief description of the estimated expertise, analytical steps, costs, and timeline (i.e. "Scope of Work") required to develop an actionable watershed-wide data call for the information necessary to track progress on 2014 Chesapeake Bay Watershed Agreement Vital Habitats Outcomes. This description will be submitted to Garrett Stewart (stewart.garrett@epa.gov) in time for posting to the January MB meeting page by January 7, 2021 and for discussion at the January 21, 2021

<u>Action:</u> The Climate Resiliency Workgroup and all Management Board representatives will submit their requested climate indicators (with appropriate, brief descriptions) to Breck Sullivan (<u>bsullivan@chesapeakebay.net</u>) no later than December, 3, 2020. STAR will then work as appropriate with the submitters to compile a descriptive list and submit to the CBP office for posting on the Management Board website no later than January 7, 2021. The Management Board will review the posted list in advance and come prepared to discuss and prioritize at their January 21, 2021 meeting.

Action: The Climate Resiliency Workgroup will work with other CBP Workgroups as appropriate to combine, briefly annotate, and bin into their recommended "High", "Medium", and "Low" priority categories the "Phase III WIP BMP's: Drivers for Implementation between 2019-2025". The purpose is to identify the highest priority BMPs on which to seek funding for research on the climate change impacts to BMP performance. The resulting list will be submitted to Garrett Stewart (stewart.garrett@epa.gov) for posting on the Management Board website no later than January 7, 2021. The Management Board will review the posted list in advance and come prepared to discuss, prioritize, and identify next steps at their January 21, 2021 meeting for subsequent submission to the PSC. Included in "Next Steps" may be the option to schedule brief working sessions between the CRWG, CBC, and appropriate Workgroups to scope out specific research needs on the highest priority BMPs.

<u>Action:</u> The CRWG will be prepared to present and the Management Board will be prepared to discuss the CRWG's request to, "Engage managers and other CBP partners for use of Bay-Wide Climate

Resilience Scorecard - identify potential stakeholder users." This is the CRWG 3rd bulleted request that we didn't get to. Relevant background materials will be submitted to Garrett Stewart (stewart.garrett@epa.gov) for posting by 1/7/21.

Action: The CRWG will be prepared to present and the Management Board will be prepared to discuss the CRWG's request to "Support more staff resources for Climate Resiliency Workgroup (CRWG full-time staffer, technical analyst)" This is the CRWG 4th bulleted request that wasn't discussed during the meeting. Relevant background materials will be submitted to Garrett Stewart (stewart.garrett@epa.gov) for posting by 1/7/21.
