Federal Planning Goals Status Review and Climate Milestones Discussion (John Maleri) Outcome: Review and discuss allocation of additional climate change reductions for Federal Agencies.	10:10- 10:50	 Questions and Comments Kevin-Meeting with FFWG will have with WQGIT leadership, open to people, or see an outline of the conversation? How can I provide input into that discussion? Soliciting info on affected DOD installations might have background info that would be helpful. Don't want to see this happen in a vacuum. John- will take this back to Greg, see if Kevin can join meeting given DoD level of involvement. John recommended members review the final published Federal Agency Progress Evaluation and share with MB or other team members who should see it. Hope is to have more firm information from jurisdictions in terms of requiring additional load reductions from federal agencies based on climate change. Kevin- DoD does the data call to facilities in July. We won't be able to adequately address the 2-year milestones if we don't know what the jurisdictions are requiring, what the magnitude is. Need to develop a strategy. Hoping to have definitive acknowledgement from the jurisdictions as to which ones will require additional load reductions. D.C. has said no, WV said no, VA said yes.

		 James- VA has climate allocations by state basin, also be fine with a "DoD has 2% of VA CB watershed, DoD would get 2% of VA's N, P and S type allocation. Do not have any better way to parse it out, looking for the approach. Ted- Like James, PA would use proportional assessment, welcome programmatic narrative as well. May be some issues regarding numeric targets, but a programmatic narrative could address that need without having definitive land use loads for federal facilities directly. Cassie- Will reach out to NY leads to confirm. If we did it proportionally it would be very small. Kevin- Need MD and WV, would rather have something directly from jurisdictions on their expectations. What are other agencies doing, how are they going to develop milestones? Liz- agree that it's too late to add new requirements for July data call. We are still just trying to figure out how to count any BMPs. It takes lead time. Shawn- NPS team call scheduled for this afternoon, will get this on the agenda. John reviewed the Federal Planning Goals, (Table 3-1. Assessment of Phase III WIP FPGs) from Brown and Caldwell's evaluation. D.C. is having internal discussions about our components and hopefully scheduling a meeting to talk through these equity issues. No questions or comments.
Federal Agency Progress Evaluation (John Maleri) Outcome: Next steps to continue working towards a complete and accurate BMP record.	10:50- 11:20	John discussed some of the preliminary efforts to continue Brown and Caldwell's federal agency evaluation work and solicit input from jurisdictions on what gaps they would like to see addressed. One option is to complete the historical BMP and record and get a true baseline. Questions and Comments Kevin- DoD has been working to improve their data, appreciate the cooperation in D.C. Katie- USFS hasn't had a change, struggle since can't quantify any forest harvesting BMPs in CAST because harvested forest isn't a federal land use. That's our major roadblock at the moment. Shawn- NPS retained a consultant to help build out a robust data set and progress report.
