Land Use Methods and Metrics Development				
Delegate updating of jurisdiction- specific datasets to the jurisdictions (e.g., MS4s, protected lands, sewer service areas, and zoning). This will help free-up resources to work on this outcome.	The Land Use workgroup requested jurisdictions update specific datasets to help the workgroup ease its workload and focus on other CBP priorities necessary to achieve this Outcome. Maryland indicated that it could assume this responsibility, but the other jurisdictions and DOD expressed concerns with having their staff update these datasets. The Management Board recommends the Land Use Workgroup meet with the Water Quality GIT and EPA region 3 GIS team. During the meeting, the workgroup will discuss what needs to be accomplished, the impacts on staff time, and what the consequences will be to other CBP priorities if this responsibility remains with the Land Use Workgroup. 	To help improve the collection of this data, the Land Use workgroup will draft a brief document for the Management Board detailing clear requirements and specifications about the needed datasets, lessons learned and common errors observed during data collection, frequent obstacles/challenges that delay finalization of the dataset, and the impacts on CBP staff and other CBP priorities if this responsibility remains with the Land Use Workgroup. The document should include recommended next steps, including appropriate roles and responsibilities, from the joint meeting of the Land Use Workgroup and Water Quality GIT.	
Adjust the outcome language to extend the completion date to December 2021.	The Land Use workgroup's request to adjust outcome language to extend the completion date to December 2021 is dependent upon their request to ease the burden of collecting certain datasets. Therefore, the request concerning data collection needs to be addressed first. However, the Management Board did state that if the deadline is extended, then the Land Use workgroup will need to set interim deadlines to meet certain needs, such as the Partnership decisions related to addressing climate change.
