

Monitoring based on all the current updates and activities occurring with the CBP Monitoring Program.

Trees

- Members could take part in a tree planting or tour a green infrastructure project.
- Tie-ins to DEIJ and climate change: urban heat islands, redlining, etc.
- Jurisdictions will release updated forest action plans in June.
- Forest buffers are currently a lagging outcome for the partnership.
- If we focus on trees, can we tie in wetlands as well?
- At the 1996 meeting, members helped with a tree planning to commemorate the first forest buffer goal set in Pennsylvania.

Role of the federal government in the partnership

- With a meeting in Washington, D.C. topics should center around the role of the federal government in the partnership.
- Focus on new funding opportunities.
- Build in capacity-building, workforce development, corporate sustainability partnerships and public-private funding opportunities.
- How do we make this actionoriented?
- Aligning federal and Chesapeake Bay priorities (climate change, DEIJ)
- Possible to tour a restoration site that federal funding helped achieve?





Consideration of new threats

- Climate change
 - Follow up on actions taken since the 2021 climate directive was signed.
 - Addressing flooding, river flows across the watershed.
 - Population growth, declining wildlife habitat.
- Agricultural resilience
 - Resilient Farms Initiative.
- Upcoming Comprehensive Evaluation of System Response (CESR) report from Scientific and Technical Advisory Committee (STAC).
