# Update on Diversity, Equity, Inclusion, Justice (DEIJ) Efforts at the CBP



## DEIJ Statements from the Executive Council and Principals' Staff Committee (PSC)

In August of last year, the Executive Council announced a **DEIJ Statement** that affirms the partnership's commitment to embrace DEIJ in all areas of the Chesapeake Bay Program.

The Principals' Staff Committee announced an accompanying **DEIJ Action Statement** articulating their commitment to implement the recommendations in a CBP DEIJ Strategy that was developed earlier in the year by a DEIJ consultant.

In the fall of 2020, the Principals' Staff Committee tasked a new **DEIJ Action Team** with developing an implementation plan for the CBP DEIJ Strategy and exploring the options for incorporating environmental justice and community feedback into the CBP structure, by standing up a community advisory board or another method such as integrating underrepresented perspectives into one or more of the existing advisory committees.

# DEIJ Action Team "Vision"

### **DEIJ Strategy Implementation Plan**

 Develop roadmap for implementing the CBP DEIJ Strategy, identifying additional actions, subtasks, steps, and resources needed to ensure implementation by end of 2025. A draft implementation plan was developed in mid-February.

### Incorporating Environmental Justice and Community Feedback into the CBP

Develop recommendations for integrating feedback from environmental justice and community leaders into the CBP structure. This could include establishing a community advisory board composed environmental justice leaders and representatives from underrepresented groups, or another mechanism.

### **Outreach and Communications**

Engage underrepresented communities in the development of the implementation plan and recommendations for integrating environmental justice and community leaders' feedback. Use the engagement process as a foundation for organizational change and meaningful and long-term engagement with underrepresented communities.

# PSC Charge to the Climate Change Action Team

- Update the EC position on climate change by modifying the existing language of the 2014 Chesapeake Bay Watershed Agreement or preparing a new EC Directive.



## Draft CWIP Next Steps

- SC is still digging into comment details, working with EPA and grantee on proposed draft responses, and recommending revisions to a draft final CWIP (target of March 24).
- The draft final CWIP will be brought back to PSC for approval to send to EPA for final evaluation (targeting late May/June).
- Receive EPA final evaluation and make any needed revisions before posting the final WIP on the Bay Program Web site along with the final Financing Strategy and responses to comments (target of Summer 2021).
