Gateways Funding Update (Bob Campbell/Jackie Kramer, NPS)

- NPS Chesapeake Bay Office is waiting to for FY2019 appropriation results.
- Funding will support public access qualitative and quantitative goals, helping to increase the quantity of open sites as well as quality and maintenance.

Other Items/Concerns Brought Forward by Team Members (All)

Erik Zlokovitz: three new license free fishing areas (LFFAs):

- Perryville Ice House Park Within the park boundaries of Ice House Park downstream of the Route 40 bridge on the Susquehanna River (Cecil County).
- Greensboro Waterfront Park Upstream of the Sunset Avenue bridge within park boundaries on the Choptank River (Caroline County).
- Crisfield City Dock City dock/depot area at the end of West Main Street (Somerset County).
- There is no entity between Maryland Department of Natural Resources and the Department of Tourism.
- Fish and Hunt Maryland will be present at the Great American Outdoor Show in Harrisburg in February, 2019.

Bob Campbell:

- Captain John Smith Trail moved to Colonial so the mission of the NPS Chesapeake Bay Office will focus on stewardship and how to increase engagement with the Chesapeake Bay Program.
- Chuck Hunt is leaving the NPS Chesapeake Bay Office and moving to New Orleans.

Robbie Rhur:

- Uncertainty with LWCF funding.
- Memorandum of Understanding funded two years ago to improve bridge crossings. Virginia Department of Transportation has shown support.
- New public access sites opening on Lower Rappahanock water trail before 2019.
- Virginia Outdoors Plan Maintenance funding gap remains an issue.

Mark Hohengasser:

- New York State Parks is awaiting public access data from the Department of Conservation.
- New boat launch has opened at Glimmerglass State Park in Cooperstown.

John Davy:

- Whitewater Park, Turkey Island Creek, and at least two other public access sites will have opened in VA in 2018.
- Clarifying point: sites can have multiple openings and still be recognized as separate sites in the site count data.

Bob Campbell:

• An award was made in 2017 that will support new kayak launch in Whitewater State Park and other paddle-in camp sites.

Jackie Kramer:

- Mapleton Borough established new kayak/canoe launch and paddle in campsite in PA.
- Executive Director, John Arway has retired from the PA Fish and Boat Commission and will be replaced by Tim Schaeffer.
