The PSC approved the final Conowingo Watershed Implementation Plan (CWIP) in September 2021. The CWIP identifies strategies for an additional reduction of 6 million pounds of nitrogen and 0.26 million pounds of phosphorus needed to mitigate the water quality impacts of Conowingo Dam infill. The CWIP Steering Committee will present an update on draft numeric and programmatic milestone documents. Approval of the draft milestone documents will be requested at the November CWIP Steering Committee meeting on November 16 (one week prior to the PSC).

The CBP needs to address challenges with weakening/declining monitoring capacity due to flat funding and cost increases. He provided ideas for how the partnership can improve capacity (better technology including AI, better accounting, cost efficiencies, etc.). The PSC endorsed a plan for conducting an analysis and making recommendations to address expanding gaps in capacity for existing monitoring, and investments needed to make program improvements. Lee will provide a brief update on CBPO's progress in carrying out the plan.
