10:15 AM **2019 Updates to the Point Source Tool** – Megan Thynge, EPA (30 min)

Megan will go over new features to the application to make 2019 progress submission easier for states.

Summary:

The point source tool is comparing historic data to point-source files in CAST to make sure they are getting closer to one "official" wastewater data set. The changes were made to feature enhancements. This is supposed to make it easier and closer to what jurisdictions are used to in terms of submitting documents to the Bay Program. Reminder from 2019 grant guidance: expectation is that states will use this application for submission. 2019 Data Submission deadline is December 2nd.

10:45 AM <u>WWTWG Governance Protocols</u> – Ed Dunne, DOEE (15 min)

Ed Dunne will discuss WQGIT governance procedures and how WWTWG could use these as a model for their own governance.

Summary:

Governance Protocol: many of the WG's don't have a policy by themselves, but they follow a protocol used by the GIT. Revisit the protocols at any time. 3 main components:

- 1. Clearly articulate and use transparent decision-making process, with an emphasis on consensus building approach.
- 2. Establish a definition for membership at thee WQGIT level
- 3. Describe a communication process for identifying cross-sector issues that require a decision by the WQGIT.

For decision making, WWTWG would follow a five step process:

- 1. Discussion of the item
- 2. Formation of a proposal
- 3. Call for consensus
- 4. Identification and addressing of concerns
- 5. Modification of proposal
